The meeting was called to order by Chair Hernandez.

Gene Davis made a motion and was seconded by Dottie Conerly to approve the agenda with the addition.

Minutes: Diana Youmans made a motion and was seconded by Dottie Conerly to approve the 4/14/15 minutes as presented. Motion passed unanimously.

Gene Davis made a motion and was seconded by Dottie Conerly to approve the 4/28/15 minutes as presented. Motion passed unanimously.

Florikan Landlord's lien waiver

This waiver is the second one to be done with a different financial institution. The board was presented with one from a different financial institution at last month's meeting.

Monica Reas made a motion and was seconded by Gene Davis to approve and authorize the Chair to sign the waiver.

Community Redevelopment Agency loan request

Jessica Newman and Olivia Minshew, both with the City of Wauchula, were here today for a loan request from the IDA. The CRA has an incentive program from businesses in the CRA district and Marauder Properties has approached them to take advantage of the incentives offered. Marauder Properties have owned Dr. Fallon's practice since 2013 and they are looking to expand. An urgent care center will be added to Dr. Fallon's office. They then plan to expand and build a diagnostic center at 7th and Bay St. They are hiring different positions and plan to have 17 FTE over the next two years.

The CRA would like to help them move along. They have \$50k allocated in their budget and are seeking a forgivable amount of \$200k from the IDA. There is criteria to be met for the funding to be disbursed. The CRA funds would be used first. Before any IDA funds are expended, the CRA would provide us with documentation that they deliverables required have been met. This will be structured more like a grant than a loan since there will be no money to be paid back. If the deliverables have not been met then no money would be given to the CRA. The CRA attorney and our attorney will work on the structure of the document.

Donald Samuels made a motion and was seconded by Monica Reas to appropriate the \$200k and bring back a draft to the Board. Motion passed unanimously.

RFP for legal services

Attorney Evers has provided a draft rfp for legal services. He briefly went through the rfp and tried to put a catch all in the scope of services. Discussion was had on where and for how long to advertise. Attorney Evers can advertise in the Florida Bar News. It goes out once a month. It was also suggested to advertise in the Highlands Today, Lakeland Ledger and the Herald Advocate.

Gene Davis made a motion and was seconded by Diana Youmans to approve the RFP and to advertise where discussed for 60 days. Motion passed unanimously.

Staffing discussion

Since Sarah Pelham as announced her resignation, we have an urgency to get someone in her place. Chair Hernandez has also worked on a review process. These were shown to the board. Every board member would participate in the review process. It would need to be changed to fit each person's job description. The EDC Coordinator position would need 4 key areas; financial/accounting, project and construction management, contract and grant management and a general area of knowledge. The current job description does not have a physical requirements and education section. These need to be added. The education section will say Bachelor's degree preferred or equivalent work experience.

Diana Youmans made a motion and was seconded by Dottie Conerly to allow the staff and Chair to refine the job description and advertise the position. The job will be advertised until filled. Motion passed unanimously.

Discussion related to leasing surplus Incubator space.

Director Lambert would like permission to lease Incubator space for the non-air conditioned portion at \$2 sq/ft on a short term basis. There would be no retrofitting required and it is the very back space of the building. There are currently 3 entities interested in leasing space there for storage. Lease agreements will be drafted and brought back to the board for approval.

Project Updates

Incubator-3 companies are looking to utilize the facility.

Park Expansion-no legal updates. A bank has acquired property adjacent and may be a good expansion project for us.

Florikan-We are hoping to have the CO by early or mid-June.

Project Crocodile- needs natural gas

Project Business Expansion- needs natural gas and industrial zoning

Project Unnamed- needs rails and industrial zoning

Project Night-ag diversity project that needs a Major Special Exception

Project Evergreen- ag diversity project that needs natural gas and a special exception
Fort Green LNG- needs natural gas and has it special exception

Financial Report

Sarah Pelham reviewed the EDC and IDA financials from the previous month.

A motion was made by Monica Reas and seconded by Gene Davis to approve the EDC and the IDA financials. Motion passed unanimously.

**Hardee County Industrial Development Authority
City of Wauchula Community Redevelopment Agency
Funding Agreement**

THIS AGREEMENT ("Agreement") by and between the Hardee County Industrial Development Authority (the "IDA"), a dependent special district and The Community Redevelopment Agency of the City of Wauchula ("CRA") is set forth as follows:

RECITALS

WHEREAS, The City of Wauchula Community Redevelopment Agency, a Dependent Special District was created by the Florida Legislature to solicit, rank and fund grants for economic development for and in the geographic boundaries of Hardee County, Florida; and

WHEREAS, The IDA, a dependent Special District was created by the Florida Legislature to foster and promote economic development in Hardee County, Florida, activated by resolutions 84-10 and 96-31 of the Hardee County Board of County Commissioners; and

WHEREAS, Exhibit B, Economic Development Terms of the Mosaic Development Agreement section 9D recognizes the need for health care facilities or complex set forth as follows;

"Funds may be utilized to investigate and create an economic development catalyst project such as an airport, commerce park, industrial park, alternative energy research center or health care complex, etc., to name a few examples. Other forms of government infrastructure such as schools, jails, public buildings and libraries are not considered to be intended uses of the funds contributed by Developer pursuant to these Terms. However, community centers and civic center that have visitor/tourism connectivity may be appropriate."

WHEREAS, The City of Wauchula Community Redevelopment Agency presented before the IDA Board on May 12, 2015, requesting approval of a funding

agreement between the CRA and the IDA for the purpose of supplementing funding appropriated for Marauder Properties, LLC.; and

WHEREAS, The IDA approved funding to the CRA in the amount of \$200,000 on _____; and

WHEREAS, Marauder properties, LLC owns Diego Fallon, Inc., which is a medical practice that was established in Hardee County in _____

WHEREAS, the parties believe it is in the best public interest to enter into this Agreement for the reasons set forth above; and

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises herein, the parties agree as follows:

1. RECITALS:

The above stated recitals are hereby incorporated by reference.

2. IDA COMMITMENTS:

- a. IDA Funding requested to be paid as a reimbursement upon meeting set deliverables.
 - 1) \$50,000 upon opening of Urgent Care Center
 - 2) \$125,000 upon C/O of Diagnostic Center
 - 3) \$25,000 upon creation of 17 documented FTE jobs held for a 12 month period within 5 years of the agreement.
 - a. \$1,470.59 reimbursed per FTE job (not to exceed \$25,000)
- b. The funding agreement between the CRA and IDA be _____ for a 5 year period with the option to extend if agreed upon by both the CRA and IDA boards.
- c. The funding will be held by the IDA and taken on a reimbursement basis upon proof that set deliverables have been met

3. COMMUNITY REDEVELOPMENT AGENCY COMMITMENTS:

a. The CRA commits to reimbursing Marauder Properties, LLC based on deliverables being met, set forth as follows:

- 1) \$50,000 upon opening of Urgent Care Center
- 2) \$125,000 upon C/O of Diagnostic Center
- 3) \$75,000 upon creation of 17 documented FTE jobs held for a 12 month period within 5 year of the agreement.
 - a. \$4,412 reimbursed per FTE job (not to exceed \$75,000)

b. Upon reimbursement request to the IDA, the CRA will provide a copy of the canceled check to Marauder Properties, LLC and documented proof that project deliverable has been met.

4. COMPLIANCE VERIFICATION

No later than 30 days from the end of each quarter, the CRA will provide the IDA with an update and progress report of deliverables.

5. GENERAL PROVISIONS

1. AUTHORITY

Each party represents that it has obtained all necessary authority to enter into this Agreement.

2. RELATIONSHIP OF PARTIES

The parties will perform their respective obligations under this Agreement as independent contractors and not as agents, employees, partners, joint ventures, or representatives of the other party. No party can make representations or commitments that bind any other party.

3. LIMITATION OF LIABILITY

In no event will any party be liable to any other party for any indirect, special, punitive, exemplary, incidental or consequential damages. This limitation will

apply regardless of whether or not the other party has been advised of the possibility of such damages.

4. TERM

The term of this Agreement commences on the Effective Date of the Agreement and continues until the later of 5 years from the execution of the agreement, unless approval from the IDA has granted an extension.

5. DISPUTE RESOLUTION AND APPLICABLE LAW

a. INFORMAL MEETINGS

The parties' representatives will meet as needed to implement the terms of this Agreement and will make a good faith attempt to informally resolve any disputes.

b. MEDIATION

In the event a dispute arises under this agreement, either party may request the matter be mediated prior to filing suit in accordance with Florida law.

c. APPLICABLE LAW AND VENUE

This Agreement is made and entered into in the State of Florida, and this Agreement and all disputes arising out of or relating thereto shall be governed by the laws of the state of Florida, without regard to any otherwise applicable conflict of law rules or requirements that would require or permit the application of the law of another jurisdiction.

The parties agree that any action, suit, litigation or other proceeding arising out of or in any way relating to this Agreement, or the matters referred to herein, shall be commenced exclusively in the Circuit Court in and for Hardee County, Florida and hereby irrevocably and unconditionally consent to the exclusive jurisdiction of this court for the purpose of prosecuting and/or defending such litigation.

6. PUBLICITY

The parties agree to cooperate fully to coordinate with each other in connection with all press releases and publications regarding this Agreement.

7. NO WAIVER OF SOVEREIGN IMMUNITY

Nothing in this agreement may be construed to be a waiver of the sovereign immunity of any government entity to suit.

8. MISCELLANEOUS PROVISIONS

1. COUNTERPARTS

This Agreement may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, and it shall not be necessary in establishing proof of this Agreement to produce or account for more than one such counterpart.

2. MERGER

This document constitutes the final entire agreement between the parties and supersedes any and all prior oral or written communication, representation or agreement relating to the subject matter of this Agreement.

3. SEVERABILITY

Any term in this Agreement prohibited by, or unlawful or unenforceable under, any applicable law or jurisdiction is void without invalidating the remaining terms of this said Agreement. However, where the provisions of any such applicable law may be waived, they are hereby waived by a party, as the case may be, to the fullest extent permitted by the law, and the affected terms are enforceable in accordance with the parties' original intent.

4. SURVIVAL OF PROMISES

Notwithstanding any expiration, termination or cancellation of this Agreement, the rights and obligations pertaining to payment or

repayment of funds and/or remuneration obligation, confidentiality, disclaimers and limitation of liability, indemnification, and any other provision implying survivability will remain in effect after this Agreement ends.

5. BINDING EFFECT

This Agreement and all terms, provisions and obligations set forth herein shall be binding upon and shall inure to the benefit of the parties and their successors and assigns all other agencies, departments, divisions, governmental entities, public corporations and other entities which shall be successors to each of the parties or which shall succeed to or become obligated to perform or become bound by any of the covenants, agreements or obligations hereunder of each of the parties hereto.

6. FORCE MAJEURE

The parties shall not be required to perform any obligation under this Agreement or be liable or responsible for any loss or damage resulting from its failure to perform so long as performance is delayed by force majeure or acts of God, including but not limited to strikes, lockouts or labor shortages, embargo, riot, war, revolution, terrorism, rebellion, insurrection, flood, natural disaster, or interruption of utilities from external causes.

7. NOTICE

All notices, requests, demands and other communications will be in writing and will be deemed given and received (i) on the date of delivery when delivered by hand, (ii) on the following business day when sent by confirmed simultaneous telecopy or email, (iii) on the following business day when sent by receipted overnight courier, or (iv) three (3) business days after deposit in the United States Mail when mailed by registered or certified mail, return receipt requested, first class postage prepaid, as follows:

8. AMENDMENT

The terms of this agreement may be amended from time to time with the approval of the IDA.

REPORTS TO:

POSITION SUMMARY:

Oversee financial, project, grant, construction and administrative activities for the Hardee County Economic Development Council (EDC). The Hardee EDC staff also administer all duties for the Industrial Development Authority as designated by the board.

DUTIES/RESPONSIBILITIES:

PROJECT AND CONSTRUCTION MANAGEMENT:

- Oversee the construction management to include but not limited to documentation of bid processes, invoice management and reimbursements or purchases of construction management contractor
- Facilitate communications with construction manager and maintain project updates
- Assist in oversight of project deliverable and manage documentation and review processes

CONTRACT AND GRANT PREPARATION AND MANAGEMENT:

- Preparation and submittal of any EDA grant applications and reimbursement requests
- Oversee the grant application process
- Oversee grant management to include, but not limited to documentation to support grant contract management and documentation on deliverables
- Facilitate communications with grant recipients and maintain project updates

FINANCIAL AND ACCOUNTING:

- Manage all financial records for the EDC and IDA, including day to day operations of QuickBooks, writing checks, keeping bank accounts reconciled, transfers of money, preparation of budgets, requesting draws from the BOCC, creating budget requests. Provide oversight for all required accounting controls. **All tax documents will be prepared by the EDC/IDA accountant**
- Management of the Hardee County Commerce Park, to include collection of rent on IDA owned buildings, assisting in creation of rent agreements with tenants, facilitating RFP's for Landscape Maintenance contracts, management of awarded contracts, maintain relationship with businesses located in the park
- Management of the IDA grove, to include preparation of RFP's for grove caretaking, assisting director with fruit crop, creating budgets for caretaking and management of those contracts, collection of fruit crop checks

OPERATIONAL / RELATIONSHIP MANAGEMENT:

- Assisting in recruitment of new development
- Develop a relationship with any and all clients that the EDC is working with
- Maintain a good understanding of past, present and future projects being pursued by the EDC
- Be designated the Hardee County Enterprise Zone Coordinator: have knowledge of all E Zone incentives available, provide information to interested businesses, assist businesses with necessary paperwork, sign all paperwork to be submitted, keep records of all businesses that participate
- Assist in the management of office staff along with the Director, to include keeping office staff on task, delegating duties, assisting the hiring process for new staff, creating job descriptions, interviewing and selection along with Director
- Maintain relationships as directed with all local, regional and state Economic Development stakeholders to include, but not limited to Hardee County BOCC, Career Source Florida, FEDC, FHREDI, EDA, Hardee County Clerk of Courts
- **Any and all other duties assigned by the Supervisors and/or Board of Directors.**

- Must demonstrate a proficiency in all components of Microsoft Office

- Must wear appropriate attire for occasion. Professional dress during normal working business days.


