The meeting was called to order by Chair Hernandez.

Agenda: Monica Reas made a motion and was seconded by Gene Davis to approve the agenda as presented. Motion passed unanimously.

Minutes: Gene Davis made a motion and was seconded by Monica Reas to approve the 5/10/16 minutes. Motion passed unanimously.

FYE 2015 Draft Financial Audit presentation

Mike Carter, CliftonLarsonAllen(CLA), was here today to present the draft financial audit. CLA gave an unmodified opinion. We had \$22.4M in assets at the end of the year. There was \$7.3M in cash and \$13M in capital assets. There was one finding which was a material weakness in the amount of \$87k related to monies that should have been a receivable instead of an expense at year end. All findings from prior year(s) have been cleared except for one which is partially corrected related to the grant advances.

Lory Durrance made a motion and was seconded by John O'Neal to accept the audit. Motion passed unanimously.

Florida Pomegranate Association presentation

Cindy Weinstein, President of the Florida Pomegranate Association, was here with a presentation. She is a Hardee County resident and has a pomegranate orchard. She started out with 40 varieties and is now up to 140 varieties on 6 acres. Pomegranates do have a fungal problem due to the humidity. There is a huge marketing capability for this fruit and the whole tree is usable. Her presentation consisted of different varieties and their qualities. Cindy's orchard is open for tours by appointment only.

Request from Community Redevelopment Association

Jessica Newman, Community Redevelopment Association (CRA) Director, was here before the board today. She has submitted a letter and proposal. There have been many workshops within the County relating to the housing market. The CRA issued two separate RFP's in April 2016 that were geared towards vacant properties and retrofitting/renovating property in Downtown Wauchula which would

include a residential element. There were two responders, one for each RFP. The CRA board reviewed each submittal at their workshops as well as interviewed the developer/builder of each and determined that both projects meet the needs of the community and were worth trying to accomplish. Jessica Newman is here today asking the board if they would partner with or contribute to the CRA. Her request is for \$400,000. The CRA is putting in \$300,000. The developers have a combined total of around \$1.65M invested. These projects would take place in '16-'17 and '17-'18.

Director Lambert would like the contract to be between the IDA and CRA and take the next 30-60 days to come up with something. Lory Durrance abstains due to the fact that the developers have or may have a banking relationship with his employer.

Gene Davis made a motion and was seconded by Monica Reas to accept the CRA's proposal and fund them. Lory Durrance abstains and the motion passes.

The contract will come back before the board for approval.

*A break was had from 9:56-10:10am

Brown Property Purchase Agreement

Ken Evers reviewed the agreement with the Board. He did note that the legal description needs to be changed to Lot 7, south ½ of Lot 6 and Lots 17 and 18. The IDA will be paying all normal costs. There is no due diligence period in this contract. Phase 1 on the property has been completed and it noted that there is a junk yard north of the property and recommends completing a Phase 2. This is up to the board. The purchase price is \$250,000 net to the seller subject to proration of 2016 real property taxes. Director Lambert recommends to proceed with the purchase.

John O'Neal abstains due to his employer's working relationship with the seller.

Lory Durrance made a motion and was seconded by Monica Reas to accept the purchase and sell agreement with the legal description changes and the authority for the Chair to sign all closing documents and appropriate the funding. John O'Neal abstains and motion passes.

US 17 South Utilities Extension

This is for water/sewer infrastructure on southbound Hwy 17 and Will Duke Rd. and looping back up North on Hwy 17. The EDA grant that was just awarded was in the amount of \$750,000 and the GMP came back at \$964,600. We need to make up this deficit with IDA money. We would not be able to submit for an EDA grant for this deficit since the expenses would incur before the start date of the grant if we were so awarded and we would like to start this project as soon as possible.

Monica Reas abstained due to her business being on Will Duke Rd.

Lory Durrance made a motion and was seconded by Diana Youmans to appropriate up to \$214,600. Monica Reas abstains and the motion passes.

EDA grant submissions

The EDA cycle this year will be June 1- June 30. We will be submitting 4 applications. They will be for EDC funding, water/sewer corridor, incubator and pretreatment facility. We do not have the final totals on the amounts for some of the submissions. We will have those by the next board meeting and can let the board know the final amounts that were requested in the grant applications.

Lory Durrance made a motion and was seconded by Gene Davis to approve the grant application submissions. Monica Reas abstains due to her business being on Will Duke Rd. Motion passes.

Project Updates/Chair Updates

Director Lambert told the board that he would like to submit a written report in the next few weeks. PFM has a damaged circuit switch and is unable to run any of their equipment. It was damaged by either lightning or voltage fluctuation. The cost to repair is about \$62,000. We first need to determine the cause of the failure before any repairs are made. TechRiver is at 95% capacity. Caresync is at 150 employees and have vacancies of about 20. They have put up billboards in Hardee and Highlands County. The Botanicals and Olives are moving forward and the land has been cleared. The olive bids have also been received by the office. The Sheriff would like to construct a building behind the Command Center for equipment. Director Lambert will work with him on the drawings and make sure that it fits the architectural style of the Commerce Park.

Chair Hernandez said in the last meeting that she would bring back job descriptions from the County that would be comparable to the duties and pay grades for our office. Sarah Pelham would be placed in the pay grade of 32 which is \$57,074.46 and Kristi Schierling would be placed in a pay grade of 23 which is \$33,956.00. Chair would like for the board to consider adopting the grades and salary ranges for these grades and to also bring Sarah Pelham to an appropriate salary level. She has worked here for 8 years with no salary increase.

*short break to review County step plan 11:25-11:32am.

Discussion was had on where to place Sarah Pelham in the step plan.

John O'Neal made a motion and was seconded by Monica Reas to bring Sarah Pelham to grade 32 year 8 and Kristi Schierling to grade 23 year 5 to begin in the next payroll cycle and to follow the county step plan as a guideline. Motion passed unanimously.

Financials

There is a special revenue budget amendment adding Project Olive and Florikan additions into the budget and removing Project Malinda from the budget.

Diana Youmans made a motion and was seconded by Lory Durrance to approve the special revenue budget amendment. Motion passes unanimously.

The EDC/IDA financials were accepted as presented with a motion by Monica Reas and a second by John O'Neal. Motion passes unanimously.

Announcements

The Chamber of Commerce has requested that the EDC/IDA sponsor a Lunch N Learn. The cost is \$500. There is no board approval needed for that amount. The Florida Hospital Groundbreaking was held at the end of May.

**FIRST AMENDMENT TO
Peace River Paddle Sports & Kuleana Adventures, Inc.
Sub-Grant Agreement
Effective April 12, 2016,
BETWEEN
Hardee County Industrial Development Authority,
a dependent special district
AND
Peace River Paddle Sports & Kuleana Adventures, Inc.**

This first amendment to agreement is made and executed by and between the **Hardee County Industrial Development Authority, a dependent special district** (the “**IDA**”), and **Peace River Paddle Sports & Kuleana Adventures, Inc., a privately held company** (“**PRP/KA**”), for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as follows:

WHEREAS, the parties entered into that certain Peace River Paddle Sports & Kuleana Adventures, Inc., Sub-Grant Agreement with an effective date of April 12, 2016, and an initial ninety (90) day term (expiring on July 11, 2016); and,

WHEREAS, the Hardee County Economic Development Authority (“**EDA**”) met on July 5, 2016, and approved additional funding and 90-day budget in the amount of \$35,700.00; and,

WHEREAS, PRP/KA spent \$29,300.00 of the initial 90-day budgeted amounts of \$47,900.00.

Based upon the foregoing recitals, it is hereby AGREED:

1. The above-stated recitals are hereby incorporated by references as if fully set forth herein.
2. The term of the sub-grant agreement is extended by ninety (90) days through October 9, 2016.
3. Funding of an additional \$35,700.00 (based on and in accordance with Exhibit “A” attached hereto) is approved. Total approved funding to date is \$65,000.00 (\$29,300.00 + \$35,700.00).
4. Monthly progress reports shall be made by PRP/KA to the IDA.
5. All other terms and conditions remain unchanged and in full force and effect.

The effective date of this agreement is July 12, 2016.

The parties have caused this First Amendment to be executed by their duly authorized representatives on this ____ day of July, 2016.

Experience and Capacity

The John Scott Dailey Florida Institute of Government (FIOG) was created by the Florida Legislature in 1980 and subsequently designated as a Type I Institute by the Florida Board of Regents. The institute fulfills its statewide mission through a consortium of six (6) affiliate program offices. Each affiliate program office serves a corresponding regional geographic service area within the state. The mission of the John Scott Dailey Florida Institute of Government is: "*to increase the effectiveness and quality of government in Florida through applied research, training, technical assistance programs and public service.*"

With over 20 years of experience in the local community, the Florida Institute of Government at the University of South Florida has a vast history of helping government and non-profit entities through visioning and strategic planning processes, offering and coordinating trainings, technical assistance, and applied research projects for the local community.

Understanding of Need

The FIOG understands that the Hardee County Industrial Development Authority (IDA), a public organization, is seeking assistance with the development of an Economic Development Performance Report which will consist of an economic and fiscal impact analysis of the IDA's economic activities over the past five years. The IDA is requesting these services from an outside organization that has broad based economic development and analytical research experience as well as access to university faculty, staff and consultants specializing in economic and fiscal impact analysis expertise in the economic development field.

On January 7, 2013, the FIOG was awarded a contract to complete an Economic Development Performance Report for the Hardee County IDA for the time period of 2006-2011. The Hardee IDA's purpose was to foster economic development and diversification through job creation, facilitation of infrastructure development, and growing the tax base. Specifically, the FIOG looked at the projects that came to Hardee and the on-going economic impact on the area. A final report with key findings for the 6 companies reviewed was submitted to the IDA on October 28, 2013.

Some of the key findings from the report included the following:

- The IDA owns a 264 acre Commerce Park which opened in 2005 that generates revenue from land transactions.
- Big economic downturn occurred in 2004 with Hurricane Charley, initially insurance moneys and government support money related to hurricane recovery bolstered the economy. By 2007, the impacts of the national economic downturn exacerbated the local economy.
- There was then a legislative directive to the Hardee EDA to solicit, rank and fund job creation and infrastructure projects in Hardee County.
- ED funds had been used primarily to fund infrastructure such as water for drinking, irrigation and fire suppression, waste water treatment and effluent disposal, the Commerce Park to recruit businesses and also roads and storm water systems. This investment led to the recruitment of businesses and job creation that otherwise would not have occurred in the County especially during a national recession.

In June 2016, Keith Rupp, Tucker Hall Communications, reached out to the FIOG on behalf of the Hardee County IDA to seek a proposal for an updated Economic Development Performance Report. On June 20th Angela Crist, Director of the FIOG, and Keith Rupp met to discuss the possibility of a project with the Hardee County IDA. Then on June 28th a conference call was conducted with Keith Rupp, Sara Pelham (Hardee County IDA) and the FIOG Team to discuss the proposed scope of work. The proposal outlined below is based on the teleconference discussion.

Recommended Approach

The FIOG will complete an economic and fiscal impact analysis of the IDA's economic activities from 2012-2015. The analysis will include projecting the economic impact of the IDA's economic development projects, along with revenues that these projects generated for taxing districts during (1) their construction and (2) operations.

Economic Impact During Construction

The economic impact during construction will include projecting direct and indirect economic output, jobs and salaries produced by the construction activities along with revenues that these projects generated for local taxing districts.

Economic Impact from the Operations of Projects

The economic impact from the operations of the projects will include the following direct and indirect economic impacts:

- Amount of direct and indirect and revenues by the operations of projects and spin-off revenues of companies supplying goods and services to the projects and workers and their families
- Number of new direct and indirect jobs created in the area
- Salaries to be paid to these workers
- Number of new workers moving to the area
- Number of new residents
- Number of new school students
- Taxable sales expected in the area
- Additional revenues for local motels from out of town visitors
- Additional residential and commercial property added to local tax rolls

Indirect and induced impacts will include identifying spin-off revenues that will be generated, along with the number and types of jobs and salaries for new or existing spin-off businesses created in the area.

Tax and Other Public Revenues that the Projects Generated

Further, these economic impacts will be translated into revenues for each local taxing district in the area, including:

- Sales taxes
- Property tax new residential property and commercial property on local tax rolls
- Utility revenues for cities, the county and/or other public providers of utilities
- Utility franchise fees to be collected by the city, county, and/or other public provider of utilities
- Hotel tax taxes
- Other taxes and user fees

The IDA's Operating Costs and Public Incentives Provided to Its Economic Development Projects

The analysis will include calculations of the IDA's operating costs during the past four years, along with the value of public incentives and tax exemptions provided to its economic development projects.

Calculations of Rate of Return on Investment on the IDA's Activities

The analysis will calculate a rate of return on the public's investment in the IDA's activities and economic development.

This will include comparing (1) public funding provided to the IDA for its economic development activities and public incentives provided to economic development projects during the past five years to (2) tax and other public revenues that these projects generated over ten years.

Here is an exert from the 2006-2011 Report by the FIOG Team:

The Hardee County Industrial Development Authority supported several projects from 2006 through 2011. These projects result in a significant on-going economic impact on the area and help diversify the County's economy. The table below shows the cumulative increase in revenues for area businesses, or economic output, over the period. By 2011, the firms supported by the Authority over the last six years generated direct, indirect and induced revenues for area businesses of \$161.3 million.

A total of 133 direct permanent jobs were created by these businesses. In total, 181 permanent direct, indirect and induced jobs were created by these businesses in Hardee County as shown in the table below. Over the six-year period, it is projected that these employees were paid approximately \$37.9 million in workers' earnings.

Employment in Hardee County increased from 7,254 to 7,646 or 392 workers from 2006 through 2011. Employment by firms directly supported by the Hardee County IDA (133 jobs) account for 34% of the County's employment increase. Including the indirect and induced job creation by supported projects, Hardee County IDA's activity accounts for 46% of the County's total increase in employment.

Data

The IDA will provide data on its projects to include the following information:

- Name of the Organization
- Years for which an impact analysis is requested
- Number of persons employed by the IDA
- Any additional explanation of the IDA's funding for its operations, in particular distinction of public and private funds
- Number of economic development projects that located, expanded or were retained over the period to be analyzed
- Name and investment of each economic development project, such as real property improvements, land, business personal property, etc.
- Name and cost of new constructions (real property improvements)
- Number of employees, salaries, sales, purchases and out-of-town visitors (if applicable)
- Public/ and private incentives provided to the projects
- Property tax exemptions provided to the projects

The FIOG will provide the IDA a excel template for the above mentioned information.

The FIOG will gather community information for the analysis, such as tax rates, and other information that may be needed for the analysis.

The FIOG will use appropriate US Department of Commerce RIMS II regional economic multipliers for the analysis and use those multipliers in the analysis to project spin-off benefits from the projects and its workers.

Reports to be Prepared

The FIOG will prepare a draft report showing the results of the analysis and provide that draft report by email to the IDA. The report will show the economic and fiscal impact of the IDA's projects or activities on local taxing districts. The FIOG will make changes to the draft report, as suggested by the IDA and prepare and provide a final report incorporating these changes and transmit that report by e-mail to the IDA.

Project Timeline

The FIOG anticipates the completion of the **Updated Economic Development Performance Report** within five weeks of the time that the FIOG receives data from the IDA to complete the analysis and sooner, if time is of the essence for the IDA. The project could begin within two weeks of a signed contract.

Investment

The estimated project investment for the Hardee County IDA is \$21,320.00 for the **Updated Economic Development Performance Report 2012-2015**.
