Item 4.1. Florida First Capital Finance Corporation

William Wilson, Vice President of FFCFC, came before the Board today to discuss the SBA 504 Loan program. Florida's First Capital is a US Small Business Administration Certified Development Corporation. A CDC is a nonprofit organization certified by the SBA to provide 504 loans to small businesses. Mr. Wilson handed out an informational packet and it is on file at the EDC office. Director Lambert said to William Wilson that he would like for him to come and speak at a future FHERO meeting.

Item 4.2. CRA- Community Redevelopment Plan

Jessica Newman, CRA Director, was here to invite the members to the series of meeting for the CRA Master Plan update. This will be held on January 29th. There will be a series of meetings with different groups to provide information and ideas for the next set of projects and goals. The last update was done in 2010. Since then, many projects were completed that were listed in the Master Plan. Mrs. Newman gave a set of examples of the types of projects that have been completed from the current Master Plan. The parking lot renovation and stormwater work were just a few of the named. Jessica Newman also announced that the Ghost Tour tickets are on sell now.

Item 4.3. Caresync Update

Amy Gleason gave the Caresync update. She mentioned that Caresync recognized as the national leader in chronic care management. There are currently around 120 employees in Hardee County with 39 open positions. There will be a future need of an additional 40 more open positions. They are currently working with a Florida certifying body to create a new care coordination certified professional program. Travis Bond has been working with designers and architects for the old Winn Dixie building. SFSC is wanting to meet with them about possibly doing an in house training program for them.

Item 4.4. Hardee Fresh Update

Halton Peters gave a quick background for the newer members and an update of where Hardee Fresh is. They will be growing leafy greens in an indoor vertical farm hydoponically. Their day one employee count is planned to be 25 and this will scale up as they move forward. They anticipate ordering steel and hope to be under construction by the end of the first quarter. Halton said that he would be highly disappointed if by March they do not have the racking under construction.

Item 4.5. PFM Update

Director Lambert read an email from Veronica Hurst letting everyone know of Shawn Okun's passing. PFM does have a board and they do plan to continue on with their operations. The building is currently closed this week so business matters can be put into order for the continuation of business.

Item 4.6. Ag Test Plot Update

We only had one responder to our farming ad. They have paid us \$6,000 to farm for one season. Michael Garcia will be doing some video work out in the olives. Both of the grants that we applied for with Mote Marine were denied.

Sarah decided to go ahead and submit our application with a 50/50 match. DEO also announced that they had received over 200 applications with an asking amount of \$269 million. The grant is only for \$85 million.
