#### Item 3.2. 3198 : One Hope United Lease Termination Discussion

Director Lambert has a lease termination for One Hope United. R. Riveter has supplied a commitment letter to reimburse the IDA the moving costs of One Hope United. Attorney Nash reminded the board that we assumed the lease with One Hope United when we purchased the building from Victory Investment Services. Their lease does not end until 2023 with an additional one year extension. This termination agreement states that they will terminate their lease effective March 1, 2021 with compensation of \$18,200. Paragraph 16 states that One Hope United has 3 business days from the day of execution of this agreement to enter into an alternative leasehold agreement. Director Lambert stated that One Hope has found an alternate site. One Hope has stated that they would not sign a new lease until there is a lease termination in place.
