4. BOARD EDUCATION

1. Ginger Delegal- Sunshine Law

Ginger Delegal, Executive Director of the Florida Association of Counties, was here before the board today to give a presentation of the sunshine, open meetings, and public records law.

2. Kristi Schierling-Executive Report

Kristi Schierling started the executive report talking about the Celebrate Community project. This was a Hardee County civic club project that Main Street also participated in. Plants were planted along Main Street and a block of Highway 17 South. Justin Smith acknowledged Denise Grimsley for receiving the City and State Award. She was also the keynote speaker and recognized for going above and beyond. Justin Smith held an AI workshop this past month at Bertha's Kitchen. It was a great workshop with very informative information. It was facilitated by Keith Coker, President of Orlan Tech, Inc. Casa San Alfonso had their ribbon cutting in Zolfo Springs. Sarah Evers presented at Kiwanis and Justin Smith presented at Rotary in September. Sarah and Krystin Chapman are both at the Food and Manufacturing Trade Show today. 3. Stacey Dadd-SBDC Presentation

Stacey Dadd is the Associate Director of Florida SBDC. She covers 10 counties of the Tampa Bay Division. Last fiscal year, SBDC provided over half of its consulting hours in Hardee County. SBDC has been involved in different community events over the past year. The client feature was Stream2Sea. The SBDC helped them access \$1.4 million in capital. That resulted in sales of \$2.2 million and the creation of 11 jobs.

4. Justin Smith- Architectural and Engineering Continuing Services Contracts
